## **River Ythan SLA Report July 2024**

#### 1. Introduction

The Don DFSB have been contracted to carry out fisheries protection, predator surveys, spawning surveys and habitat restoration activities across the river Ythan catchment throughout 2024/25 by the Ythan DSFB under a Service Level Agreement. Each activity is allocated a set number of mandays/patrols to accommodate the requirements of the annually agreed SLA. Activities are defined following consultation with the Ythan DSFB.

Any incidents relating to pollution and policing will be recorded and shared with the Clerk. Information from predator surveys well be collated and shared with the Clerk directly following the survey period. Information on spawning surveys will be collated and reported upon in a summary report following the end of the spawning period. Any seals reported above Logie Buchan Bridge will be reported to the Clerk as soon as possible.

All activities will be covered by the Don DSFB health and safety polices, as stated in the service level agreement.

#### 2. Reporting

A log of all patrols and activities will be sent to the Clerk monthly.

SALMON FISHERY BOARD



July has been a productive month for sea trout catches at Newburgh estuary, although some fishing days were lost due to poor weather conditions. Shoals of finnock have been seen feeding within the estuary limits giving good sport to anglers.

There was one reported incident of illegal activity on the Esslemont beat, where a large amount of braided line along with treble hook and large lead weight attached was recovered. The Fisheries Officers carried out a search of the undergrowth for further evidence but nothing else was found. Permission has been granted to set up remote trail/wildlife cameras to provide monitoring of any illegal activity along with our mobile and foot patrols.

In total 10 sites were chosen on the Ebrie burn for Ranunculus weed clearing. The area selected between Drumwhindle bridge up to Glenebrie bridge (5km), exhibited areas of excellent spawning gravel. Sadly Ranunculus weed growth had smothered many sites. Following weed clearing these spawning sites have been restored allowing salmon and trout to access weed free spawning gravel for this coming spawning season, see example of before and after Fig 1 & 2 below.

#### **Pollution**

On Saturday the 27<sup>th</sup> of July there was a what looked like a sewage discharge on the Ramornie beat. Above the Ramornie beat is a Scottish Water waste treatment works which has discharge into the river it was here that the incident was witnessed.
