# **River Ythan SLA Report June to July 2023**

### 1. Introduction

The Don DFSB have been contracted to carry out fisheries protection, predator surveys, spawning surveys and habitat restoration activities across the river Ythan catchment throughout 2023/24 by the Ythan DSFB under a Service Level Agreement. Each activity is allocated a set number of mandays/patrols to accommodate the requirements of the annually agreed SLA. Activities are defined following consultation with the Ythan DSFB.

Any incidents relating to pollution and policing will be recorded and shared with the Clerk. Information from predator surveys well be collated and shared with the Clerk directly following the survey period. Information on spawning surveys will be collated and reported upon in a summary report following the end of the spawning period. Any seals reported above Logie Buchan Bridge will be reported to the Clerk as soon as possible.

All activities will be covered by the Don DSFB health and safety polices, as stated in the service level agreement.

### 2. Reporting

A log of all patrols and activities will be sent to the Clerk monthly.

Angling effort over the past two months has mainly been on the Newburgh estuary area. Catches in June were showing good numbers of Finnock, it was not till the month of July came round that catches of sea trout in numbers started to appear. Reports from anglers were positive in the range size and excellent condition of the Seatrout caught. Policing patrols were spread out between Methlick down to Newburgh estuary, with a high percentage of their time spent in the Newburgh estuary area.

Cutting of Ranunculus weed took 4 days to complete. Cutting took place from Glenebrie Bridge down Arnage Bridge at Drumwhindle. Channels were cut through the blanketed areas and the areas that contained good spawning gravel. The weed that was removed from the stream was pulled onto the streambank; this allows any aquatic life to get back into the water course. The weed was then pulled further up the embankment to rot down naturally. 2 pictures below, 1 showing the blanked affect this weed can have, the second picture showing the cut weed removed from the stream and resting on the bank edge before being taken further up the embankment.

During weed cutting I came across 3 spruce trees that had fallen over the Ebrie. The branches of the trees are causing a blockage preventing debris from passing underneath. The riverbed is bedrock at this location and therefore the channel cannot cut and scour underneath. We have concerns over fish passage as a result and partially ease this obstacle over the coming weeks. Grid Reference of Location NJ 93375/38755
